

Terms of Service for Affluid

These Terms of Service (“Terms”) govern your access to and use of Affluid, operated by **Nuvonia Media FZ LLC**.

By purchasing or using Affluid, you agree to these Terms.

1. Description of Service

Affluid is an **affiliate marketing software** that provides a self-hosted platform for agencies to manage advertisers and publishers.

Users who purchase the software may create and manage their own affiliate networks, including third-party advertiser and publisher accounts.

2. Eligibility

You must be at least **18 years old** to use the service.

3. Accounts and Responsibilities

You are responsible for:

- Maintaining account security
 - All activities under your account
 - Managing users (advertisers/publishers) within your instance
